THIS WRIT PETITION (CIVIL) HAVING COME UP FOR ADMISSION ON 07.07.2020, THE COURT ON THE SAME DAY DELIVERED THE FOLLOWING:

JUDGMENT

A Gift Deed vide No.4994 of 1998 was executed in favor of the petitioner and her husband by Smt.Rajeena, the aunt of the petitioner. Later, certain disputes arose and the executant filed a suit for cancellation of the gift deed before the Additional Munsiff, Alappuzha. The suit was dismissed finding that the gift cannot be considered to be conditional and cannot, therefore, be revoked. The said judgment was confirmed in Appeal as well. While the proceedings were pending, the executant left for her heavenly abode. The Regular Second Appeal filed by the executant was dismissed as abated by Exhibit P6 judgment of this Court. While so, she realized to her dismay that her aunt had executed a cancellation deed and had got the same registered with the Mararikulam SRO. The said cancellation deed was executed while the appeal was pending before the higher court against the judgment of the learned Munsiff. It is contended that the cancellation deed has no validity in law particularly when the civil court had decided that the gift deed is irrevocable. The aforesaid Rejeena has died without any legal heirs and in the aforesaid fact scenario, the petitioner had preferred Ext. P9 representation before the 1st respondent to consider her representation and pass appropriate orders.

2. Sri.R.Krishna Kumar, the learned counsel contends that though Ext.P9 is pending before the 1st respondent, no orders have been passed till

date. He submits that his limited prayer at this stage is to direct the $1^{\rm st}$ respondent to consider Ext.P9 and pass appropriate orders on its merits after

hearing the petitioner or her representative.

3. Having considered the facts and circumstances and the

submissions made across the bar, this writ petition is disposed of with a

direction to the 1st respondent to consider Exhibit-P9 and pass appropriate

orders on its merits, after hearing the petitioner or her representative, within

a period of eight weeks from the date of receipt of a certified copy of this

judgment.

The petitioner shall produce a copy of the writ petition along with the

judgment to ensure compliance.
