S. R. O. No. 764/2010.—In exercise of the powers conferred by clause (a) of sub-section (1) of section 9 of the Kerala Stamp Act, 1959 (17 of 1959), the Government of Kerala, being of opinion that, it is necessary in the public interest so to do, hereby reduce the stamp duty to Rs. 100 with which the instrument of partition deeds of land to be executed by the Scheduled Tribe in the State belonging to Below Poverty Line group, in favour of their family members are chargeable under the said Act.

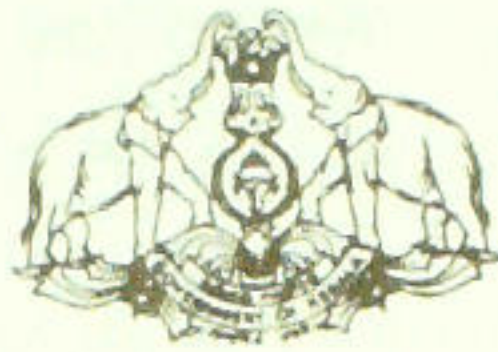
