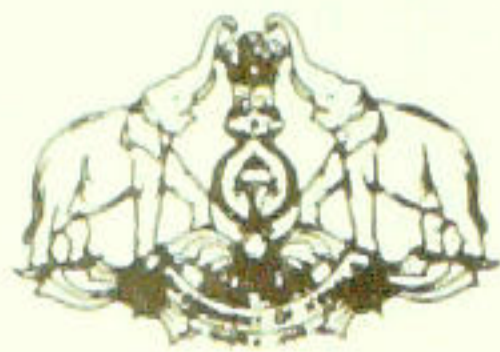

S. R. O. No. 401/2009.—In exercise of the powers conferred by section 5 of the Registration Act, 1908 (Central Act 16 of 1908), the Government of Kerala hereby make the following amendments to the Notification issued under G. O. (Ms.) No. 29/1978/TD dated 8th March, 1978 and published as S. R. O. No. 646/1978 in Part I, Section iv of the Kerala Gazette No. 27 dated 4th July, 1978, namely:—

AMENDMENT

In the Schedule to the said notification, in the registration district Cannanore in column (1),—

1. in the registration sub-district 15. Kadirur in column (2), against taluk Tellicherry in column (3), the entries “Kunnoth”, “Mannayad” and “Kavumbhagom” in column (4) shall be omitted;

2. in the registration sub-district 17. Tellicherry in column (2), against taluk Tellicherry in column (3), after the entry “kurichiyil” in column (4), the following entries shall respectively be inserted, namely:—

“Kunnoth
Mannayad
Kavumbhagom”

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per Notification issued under G. O. (Ms.) No. 29/1978/TD dated 8th March, 1978 and published as S. R. O. No. 646/1978 in the Kerala Gazette No. 27 dated the 4th July, 1978, Government have specified the jurisdiction of the registration districts, sub-districts taluks and village in the State. Now, Government have decided to shift three village of Kadirur registration sub-district to the Tellicherry registration sub-district of Cannanore registration district in public interest, for which, the said S.R.O. has to be amended.

This notification is intended to achieve the above object.
