S. R. O. No. 336/2010.—In exercise of the powers conferred by section 78 of the Registration Act, 1908, (Central Act 16 of 1908), the Government of Kerala hereby make the following further amendment to the Table of fees prescribed for the registration of documents, searching registers etc., in the notification issued under G. O. (P) No. 147/77/TD dated the 23rd November, 1977 and published as S.R.O. No. 1112/77 in the Kerala Gazette No. 50 dated the 13th December, 1977, namely:—

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The State Level Bankers Committee has requested the Government to initiate measures to register the agreement relating to deposit of title deeds by way of equitable mortgage with nominal fees. The Government considered the matter in detail and have decided to accept the request fixing a nominal fee for the registration of above kind of instruments, as announced in para 237 of the Budget Speech 2010-2011.

This notification is intended to achieve the above object.
