In exercise of the powers conferred by section 31A of the Travancore - Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 (XII of 1955), the Government of Kerala, being of the opinion that it is necessary in public interest so to do, hereby extend the period for submitting application for condoning delay in filing of returns, forms, annual statements, accounts and



other statements of a society on payment of a fine of five hundred rupees in respect of each year of delay in filing any or all of the same up to 31<sup>st</sup> March, 2023.

### Explanatory Note

(This does not form part of the order, but is intended to indicate its general purport.)

Government have implemented one time settlement scheme for condonation of the delay in filing of returns, forms, annual statements, accounts and other statements of a society on payment of a fine of five hundred rupees in respect of each year of delay in filing any or all of the same by amending the Travancore - Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 (XII of 1955) through the Kerala Finance Act, 2015 (11 of 2015). The period for availing the benefit of the scheme was up to 31<sup>st</sup> December, 2015 initially. Later, Government as per the orders issued under G.O.(P) No.9/2016/T.D dated 14<sup>th</sup> January, 2016, and published as S.R.O. No.36/2016 in the Kerala Gazette Extraordinary No.81 dated 14<sup>th</sup> January, 2016, G.O.(P) No.65/2016/T.D dated 16<sup>th</sup> June, 2016 and published as S.R.O. No.425/2016 in the Kerala Gazette Extraordinary No.1092 dated 17<sup>th</sup> June, 2016, G.O. (P)No.6/2017/T.D dated 14<sup>th</sup> February, 2017, and published as S.R.O. No.75/2017 in the Kerala Gazette Extraordinary No.265 dated 14<sup>th</sup> February, 2017, G.O.(P) No.132/2017/T.D dated 31<sup>st</sup> October, 2017 and published as S.R.O.No.678/2017 in the Kerala Gazette Extraordinary No.2352 dated 1<sup>st</sup> November, 2017, G.O(P) No.160/2018/T.D dated 8<sup>th</sup> October, 2018 and published as S.R.O.No.702/2018 in the Kerala Gazette Extraordinary No.2530 dated 9<sup>th</sup> October, 2018, G.O. (P) No. 139/2019/T.D dated 15<sup>th</sup> September, 2019 and published as S.R.O. No. 647/2019 in the Kerala Gazette Extraordinary No. 2183 dated 18<sup>th</sup> September, 2019, G.O. (P) No. 49/2020/T.D dated 1<sup>st</sup> April, 2020 and published as S.R.O. No. 269/2020 in the Kerala Gazette Extraordinary No. 1038 dated 4<sup>th</sup> April, 2020, G.O. (P) No. 141/2020/T.D dated 10<sup>th</sup> October, 2020 and published as S.R.O. No. 682/2020 in the Kerala Gazette Extraordinary No. 2338 dated 12<sup>th</sup> October, 2020 and G.O. (P) No. 86/2021/T.D dated 30<sup>th</sup> September, 2021 and published as S.R.O. No.720/2021 in the Kerala Gazette Extraordinary No. 2846 dated 1<sup>st</sup> October, 2021 had extended the period of the scheme up to 31<sup>st</sup> March, 2016, 31<sup>st</sup> December, 2016, 31<sup>st</sup> March, 2017, 31<sup>st</sup> March, 2018, 31<sup>st</sup> March, 2019, 31<sup>st</sup> March, 2020, 30<sup>th</sup> September, 2020, 31<sup>st</sup> March, 2021 and 31<sup>st</sup> March, 2022 respectively. Now, the Government have decided to extend the period of the scheme up to 31<sup>st</sup> March, 2023 in public interest.

The order is intended to achieve the above object.
